 - b. the widow of a veteran who, in accordance with the Code of Legacy, is not eligible to receive Legacy benefits.
 - c. a veteran who was a member of the Australian or Allied Defence Force.
 - d. currently on the Department of Housing waiting list.
 - e. does not satisfy points a, b, c or d above.
3. Income and asset test will be applied to any applicants, which apply under criteria (d) and (e).

PLEASE NOTE:

- Applicants will be assessed by eligibility criteria then by 'needs'.
- Residents currently pay \$290.46 fortnightly recurrent rental (adjusted each January), and pay for electricity, telephone installation and charges, which are all individually metered.
- Applicants will be required to obtain a current doctors certificate stating they are able to live in self care before their entry to the Legacy Village.
- Applicants will need to provide a certified copy of their birth certificate, drivers licence or passport for proof of age.
- Units are independent living (self care) with some at first floor level. First floor is serviced by a lift and stairs.
- Shared laundries are available, with a laundry available on the first floor level.
- There is a \$500.00 non refundable donation payable prior to moving into the village.
- There is no waiting list fee.
